## Message from the Guest Editor

We welcome contributions for a Special Issue on "Religion and Crisis in Late Imperial and Modern China", covering the period from the mid-17th century to the present.

What concepts and techniques, if any, did they provide to predict and diagnose crises? • How did individuals and communities mobilise religious practices, concepts and —where applicable—beliefs to respond to crises? In so doing, how did they navigate between tradition and innovation? Proposals including a title, an abstract of up to 500 words and a short bio of approx. 200 words should be submitted to me by 15 July 2022.
