## Message from the Guest Editors

In the mid-20th century, Latin American Christian Churches underwent a significant transformation. birthing Liberation Theology, Departing from traditional methods, this theology centered on the plight of the poor and oppressed. This shift marked the South American Churches' reception of the Vatican II Council, emphasizing humanity's overarching concerns, particularly regarding justice for the marginalized. Pope Francis's election in 2013 renewed global attention on Latin American theology, prompting a resurgence in the Catholic Church's engagement with regional issues. This Special Issue seeks contributions addressing various aspects of Liberation Theology and its implications in Latin America.
