Scholars and analysts such as Graves, D'Ancona, McIntyre, and McNair, among others, have concentrated their efforts to understanding the causes, motivations, dissemination processes, and the political, economic, cultural, and social implications of fake news. This Special Issue represents one of the greatest challenges that the media system and society at large must face today, especially during crises, emergencies, or electoral periods.
