Contributions are invited to an Open Access Special Issue of *Societies* which explores how EU-rope has been mediated in a variety of recent social contexts and how that has contributed to different forms of de/legitimation of (trans)national solidarity. We thus focus on how different meaning(s) of (trans)national identities have been constructed, negotiated and challenged not only amidst different 'crises' such as Brexit, austerity, Covid, but also in relation to new digital affordances and actors. We interrogate the production, circulation and consumption of top-down/bottom-up, institutional/public discourse of EU-rope in and by a variety of media to explain how these have related to de/legitimation processes.
