Dear colleague. The aim of this call is to raise awareness of new perspectives for intervention, as well as new methodological and theoretical challenges, in the face of the growing volume and diversification of the types and origins of migrant and refugee families, as well as children and young people, particularly those who are unaccompanied in the countries they move to. This issue invites authors from different disciplines (sociology, geography, anthropology, and educational sciences, among others) who portray different realities, as well as reception contexts and legislative frameworks, mobilizing plural theoretical perspectives and diverse and innovative methodologies. It is also important to understand the role of gender and generations in the dynamics of mobility and settling in the new country and the impact of experienced situations on the life opportunities of migrant and refugee children and young people.
