This SI is aimed at knowing why and how the migration decisions (to migrate/stay put) of people at risk (those who are vulnerable to climate risks) are made, what kind of role the social, economic, cultural, political, and environmental conditions of the respective societies and locales play in migration decisions, and how these discourses be can theoretically and conceptually grounded.
