# ESG Disclosure, Pro-environmental Behavior and Sustainability

### Message from the Guest Editor

The environmental, social and governance (ESG) disclosure is essential so that stakeholders will form positive views on the corporation. The report should motivate employees to have more citizenship, pro-social and/or pro-environmental behaviour.

On the other side of the coin, it has been argued that ESG disclosure would be limited to satisfy regulation requirements and/or positive events, thus acquiring limited and positive information from stakeholders and leading to wrong decisions from investors. "Green washings" easily occur as the field is loosely monitored. There is an urgent need to discuss the existing and future role of ESG reporting or its equivalent.

Major themes are association between ESG disclosure and firm performance; what CSR initiatives do we need to report? The association between ESG disclosure and pro-environmental intention; green washing; blue washing and carbon neutrality.
